ITEM 3 – DISCIPLINARY INFORMATION

ITEM 4 - OTHER BUSINESS ACTIVITIES

Mr. Danjczek is a registered representative of LPL Financial ("LPL"), a full service broker-dealer, member FINRA/SIPC, which compensates him for effecting securities transactions.

As a broker-dealer, LPL engages in a broad range of activities normally associated with securities brokerage firms. Pursuant to the investment advice given by Mr. Danjczek, investments in securities may be recommended for you.
